A. Details of the post:-

C. Age should be within 18-37 years as on 01.01.2017 for the posts.

keep a printed copy of the form for record purpose. Also after successful submission of online application a unique Registration no. will be generated. Candidates are instructed to remember that registration No. for future reference.

4. All application should contain the original scan copies of all testimonials to substantiate eligibility in respect of Essential qualification & Age and also to establish Desirable qualification.
